## General Terms and Conditions

1. **Application**  
The applicant sign up with signature to foreshore specified training.
2. **Confirmation**  
Right after enrollment you will receive a letter of confirmation with further details of the training course and enclosed an invoice of the course fees.
3. **Payment**  
The course fee should be completely paid latest 14 days prior the training course starts. Payments by instalments require the additional agreement in the training contract / application.
4. **Cancellation**  
Cancellations must take place in writing. Cancellations until 14 days before the course starts, a cancellation fee of 50% of the entire course fee will be charged. Later on cancellations are not possible. In that case the total course fee is due.
5. **Contents**  
The training fee includes the theoretical and practical training from a qualified instructor, the training course documents, examination as well as the certification. For exhibition of each further certification € 12.- / \$ 18,- becomes due.
6. **Check-Up**  
The participant should consult a physician and check-up before starting training.
7. **Warning**  
The course contents plan primarily the application of aggressive and danger combat tactics. Inadvertence and uncontrolled, exaggerated force, can lead to severe injuries, up to death. All participants are exhorted to act with caution!
8. **Changes**  
We reserve the right to make changes in venues and dates.
9. **Liability**  
The liability for persons and damages to property is excluded in the context of the legal possibilities. Participation in the courses is at the participant's own risk.
10. **International Terms**  
The applicant / participant hereby gives his/her consent to the international terms of the ECPO.
11. **Copyright**  
It is expressly agreed that the copyright and other related rights of the ELITE COMBAT PROGRAM (the system, training concepts, names, logos, publications, etc.) incumbent by Mr. Paul Soos. Without his written permission it is not allowed to use, duplicate or passing on even parts to third. Offences will be punished in each individual case with a conventional penalty and by law.  
  
With succeeded examination the participant will receive the license and the right to use these rights.
12. **Publication**  
By agreeing to these general terms and conditions, the participant consent to the public dissemination of photos taken or video recordings made during the training course. The participants forfeit any claims arising from such photographs and/or films.
13. **Special Services**  
Instructors will receive - as long as they are active - following cost-free services:
  - Rights to use the name and logos of the ELITE COMBAT PROGRAM.
  - Distribution rights for selling own produced ELITE COMBAT PROGRAM products.
  - Ongoing business and marketing support (Website, Flyer design, etc.).
  - Enhanced trainings (updates) minimum twice a year.
  - Exclusive assigned territory rights.
  - Listing as a certified instructor in the official website of the ECPO.
  - Access to the instructors area "Intern" (internal news, updates and downloads).
14. **Membership**  
An "active" instructor (leader of an own EP-Club or EP-Group with minimum 10 members) receives automatically a cost-free membership in the ECPO. There are no license-fees!  
  
If a "non-active" instructor want to get the same special services as an active instructor does, he or she has to pay € 240,- / \$ 380,- as yearly membership-fee.  
  
Every instructor's students have to sign up as members in the ECPO. The membership-fee for students is € 48,- / \$ 76,- per year.  
  
The instructor has the right to give two people of his choice a free membership in the ECPO.
15. **Validity**  
If any of these terms and conditions proved to be unenforceable, this shall not affect the remaining terms and conditions.
16. **Place of Jurisdiction**  
The venue for the adjudication of all disputes arising in connection with these general terms and conditions shall be the competent court for ECPO, which is the local court (Amtsgericht) of Kaiserslautern / Germany. These general terms and conditions are governed by German law.
